- I understand that this permit is for my personal use and that Auckland Transport can revoke my permit rights if permits are directly or indirectly used for the purpose of revenue generation.

- Site inspection and investigation may be undertaken by Auckland Transport prior to approving permits.
- Eden Park parking permits do not necessarily guarantee permit holders a parking space in their street.

Who can apply for a permit?

You may apply for PARKING permits if you:

- Live in one of the streets within the Resident only parking zone.

Streets in Residents only parking zone

Altham Ave, Bellwood Ave, Burnley Tce, Cricket Ave, Ethel St, Cromwell St, Collins St, Kowhai St, Marlborough St, Onslow Rd, McDonald St, Raleigh St, Reimers Ave, Rossmay Tce, Royal Tce, Sandringham Rd (numbers 1 to 183), Shaw St, Taupata St, Tongariro St, Walters Rd, Wellgarth St, Gribblehirst Rd - 50-91, Paice Ave – 43-91, Parrish Rd – 1-46, King Edward – from Paice Ave intersection to number 71 King Edward Ave, Alderly Rd, Carrick Place, Lisnoe Ave, Leamington Rd, Kamahi St, Ward Tce.

Please note that on a number of streets there will be no residents parking allowed on part, or all, of the street.

You may apply for ACCESS permits if you:

- Live or have a business in one of the streets in residents only parking, New North Rd, Bond St or New Bond St, and
- Normally park off street but need access to your residence or business through an event road closure.
